The medical clinic provides care for uninsured, low-income residents of Goodhue and Wabasha counties, supported robustly by community donations, in-kind contributions, and volunteer efforts. With nearly 100 trained volunteers, the clinic operates weekly on Tuesday evenings, staffed by over 25 volunteers per session.

4b (Code:) (Expenses \$ 839,164. including grants of \$) (Revenue \$ 523,014.)

Since its opening on May 26, 2011, the dental clinic operates four days a week, providing services such as extractions, fillings, cleanings, and x-rays to an average of 49 patients weekly.

4c (Code:) (Expenses \$ 87,039. including grants of \$) (Revenue \$ 42,950.)

The MNSure program offers bilingual insurance support to over 3,000 individuals annually, with trained staff providing free application, enrollment, and follow-up assistance to secure affordable health coverage. Additionally, our MNSure team connects individuals with other community resources as needed.
